Introduction

- Research Professors (both full time and honorary) have been appointed to help nurture early career academics;
- External reviewers have been appointed to help shape research proposals and copy-editing support is made available to help staff in getting their manuscripts published in higher impact journals;
- Internal research grants are available to provide seed money for pilot studies, with the aim of
 collecting the necessary preliminary data for substantiating full applications for competitive
 research grants, thus helping to promote the development of an individual's research
 pathway.

The number of article publications in the Science Citation Index, Social Sciences Citation Index, Art and Humanities Citation Index journals with CIHE affiliation are increasing steadily. Continuous improvement of quality is an important objective, not just quantity. The focus of research communities in CIHE, are on technology, social, healthcare, humanities and business research. We are seeking to build upon the last four years' success in fostering research capability, in a way which is fit for the purpose of informing teaching and appropriate for CIHE's distinctiveness and strengths. We are focusing our efforts and resources on translational and downstream research, practice development and where our strengths can create impact on challenges faced by the community. Our strategy is also consistent with the parallel development of the self-financing the UGC-funded envisaged post-secondary sector and universities, government-appointed taskforce, with UGC-funded universities focusing more on fundamental and excellent or world-class research.



higher education Advancement in undergone radical changes in the last 20 years. In the latter part of the millennium there has been a rise of many new categories of institutions of higher learning that have distinctly different missions and charges from traditional universities. Overall, it can be said that more is demanded of faculty in terms of workload and performance impact. Then, in the new millennium, accreditations agencies governments are asking accountabilities in the way instruction is delivered and assessment is measured.

Today, educators are enthusiastically implementing blended learning, mobile learning, ubiquitous learning, and collaborative learning. With all the push using technology mediated learning, the goal is for students to become engaged and be proactive learners.

However, incorporating more technology into the curriculum is not a panacea for academic success. During this presentation, four major shifts in paradigms about academic challenges that are forthcoming in the near future will be highlighted.

To begin, administrators and faculty will be provoked to have a systematic and shared understanding of their new academic mission. Second, both administrators and faculty be will challenged to change the way academic success is viewed, delivered, and measured. Third, "high tech and high touch" are two dependent mission critical focus areas that must be incorporated into all instructional processes because its long term impact is truly significant. Examples of the best practices involving "high touch" initiatives for the e-learning environment will be highlighted from several case studies. Last, but of equal importance are suggestions for resource allocation that must be aligned strategically and how success must be communicated.

Technology in Education Today: Potentials and Challenges

Technologies have penetrated virtually all aspects of educational establishment and delivery. Their effectiveness and value have increasingly been questioned. Some of them bring benefits, while some others not only mutate into disruptive technologies soon after emergence but also become a nuisance to education.

This presentation provides an overview on the transformation of technology-mediated education and reviews the current trends in its adoption, from the simple to the cutting-edge technology, singular to multi-level/ dimensional integrated programmes, and organisational or cultural individual to adoption. It explores how technology has revolutionized learning-modes, -materials and -space, as well as examines its potentials and challenges by drawing on relevant recent studies and analysing instances of success and failure, including e-learning, mobile learning, OERs and MOOCs. By summarizing patterns of developments, it discusses possible ways to realize the full potential of integrating technologies into education and handling challenges.

Using Online Program Management Solutions for Delivering Quality Academic Programmes

An increasing number of universities are using Online Program Management (OPM) solutions to deliver education programs. solutions are an integrated suite of online services that support university leaders, faculty, staff and students in the delivery of educational program offerings. Online Program Management has no boundaries as students from any geographical location can be recruited. This is a lucrative opportunity for tradition rich and geographically restricted campuses and programs needing accelerated numerical growth to engage. Solution components are offered in the form of a fully integrated system approach to online program management comprising of core services delivered under the brand of the university partners. Such services may include, but are

not limited to, online enablement, academic marketing services, enrollment services, services, legal compliances (accreditation and multi-state or national certifications) retention services, faculty and other personnel support, program financing, and most recently data science and analytics support. Typically, Online Program Management companies market their solutions/partnerships as capable of helping universities launch, grow, and sustain quality degree programs within a short time period. Typically, the costs can range from 45 to 80 percent of tuition revenue generated from student enrollment and the average contract range is 5 to 7 years, depending on the vendors and the array of services selected.

As expected, cases of successful as well as failed partnerships have been reported in the literature and there are many lessons that can be learned from these joint ventures. Apart from providing sufficient insight about this growing practice in higher education, this keynote addresses strategic, tactical, and operational issues that administrators, faculty, and students must understand when using Online Program Management Solutions to launch, grow, and sustain degree programs. Specifically, this presentation based on several high profile cases will 1) demonstrate the necessities of having critical success factors and detailed preparations, 2) showcase best practices that have generated revenue, and 3) highlight costly mistakes and consequences that took years to remedy. administrators contemplating OPMs as a means of support, faculty members who are developing programs and courses for online delivery, and prospective students looking for quality degree programs online will find this keynote useful and interesting.

Deploying Peer-learning Community as the Pedagogy: Critical Success Factors for Bangkok Metropolitan Administration' Schools

The study aims to identify the critical success factors for adapting Peer-learning Community (PLC). PLC represents one of several changes the pedagogical practices for the secondary-level schools at Bangkok Metropolitan Administration (BMA). The initial assessment shows that PLC improved the life skills for the students as well as has raised the level of students' enthusiasm. The study is based on the observation over the period of 3 years from 2015 until the present. Three schools under BMA's Department of Education decided to integrate PLC as part of the students' problem-based learning. teachers and students from these three schools have used the environment and ecology as the main premise on applying PLC. This premise represents how students view the environment and ecology nearby their schools and in their communities. The theme allows the students to learn either how to solve the environmental problems or how to live with their environment in a more sustainable way. As earlier mentioned, PLC is applied to help strengthen the pedagogy in the environmental

and ecological subject. The success factors in PLC stems from external knowledge to give the actual illustration of PLC, careful planning with student's involvement and the theme for projects or problems for students, the ability to sustain the motivation among teachers and students, use of ICT, and patience and trust. PLC does not only contribute positively to teachers but also stimulates students in a way that they feel that they have achieved in acquiring these life skills. Due to the success, these teachers have extended their experiences and are working with ten schools extensively outside Bangkok.

Learning Behavior and Interactive Pattern Analysis - Methodologies, Tools and Practices

Learning analytics refers to the analysis and interpretation of data related to learners' behaviors, interactive content and learning contexts recorded during learning process as well as their profiles and portfolios. The objective of learning analytics is to provide helpful information to optimize or improve learning designs, learning outcomes and learning environments based on the analysis results. In this talk, Prof. Hwang would review the current states of learning analytics research and the design considerations. To this

end, the methodologies and tools for analysing students' online learning behavioural patterns and interactive patterns are introduced. Several relevant applications are presented to show how the methodologies and tools work. It is expected that this talk can inspire researchers to discover potential research issues of e-learning or blended learning and to apply the methodologies and tools to their studies in the future.

Five Principles of MOOC Design and Development: Lessons from Two MOOCs

The Massive Open Online Course (MOOC) has been the latest disruption in online education and one of the fastest-growing segments of the education system in past ten years. It delivers open educational resources online and hence provides opportunity for people all over the world to learn anything they want to learn, anytime, anywhere. However, although MOOCs are gaining popularity in higher education, very few best practices or research in designing, developing and implementing MOOCs have been reported so far. This status quo makes it difficult for educators, course designers, and university administrators to make decisions around MOOC design and deployment given the lack of references.

Since April of 2016, the speaker and his team have provided K-12 teachers with two MOOCs: "English Teaching and the Internet" and "ICT Teaching Competencies for 21st Century Teachers: Big Five". More than 50,000 learners have registered and participated in these two MOOCs. In the keynote speech, the speaker report his work on the design, development and implementation of these two MOOCs, and share lessons he and his team learned from them. Based on learner needs, as well as a set of best practices in implementing the courses with a variety of instructional techniques supported with Web 2.0 technologies, he will propose five for developers principles MOOC instructors. The principles cover aspects of Iterating, Engaging, Peer-coaching, Social, and Mixed.







English as a Lingua Franca in Asia: Suggestions for ELT/ELF Policy and Pedagogy

Professor Kirkpatrick reviewed recently conducted research studies which used data from the Asian Corpus of English (ACE) ACE. ACE is a corpus of some one million words of naturally occurring data of English used as a spoken lingua franca by Asian multilinguals. 8 data collection teams across Asia worked together to collect and transcribe the corpus. ACE is now freely accessible and stored at the Hong Kong Institute of Education.

The studies looked at the cultural settings of topics discussed in the ACE corpus, the marking or non-marking of tenses and the communicative strategies of ELF speakers. The presentation will conclude with proposals, based on the research findings, for regional ELT or ELF policy and pedagogy.

Language Assessment in Hong Kong Classrooms: Blessing or Curse?

Second language classroom assessment has traditionally focused on the product of learning, with the teacher playing a dominant role in providing judgment of student learning at the end of instruction. Such an approach to assessment, referred to as assessment of dominated learning, has local classrooms. Assessment of learning serves primarily summative purposes, where scores suffice for feedback and students play a passive role in the assessment process. Such an assessment culture has caused both teachers and students to develop negative

attitudes towards assessment, which considered an enemy rather than a friend, a curse rather than a blessing. As a result of a paradigm shift in language assessment, the notion of assessment for learning came into use in the late 1980s and early 1990s, pivotal role descriptive underlining the feedback plays in the assessment process (Parr Timperley, 2010). This approach to assessment recognizes the importance of assessment during instruction to provide teachers with information to fine-tune their teaching and to improve student learning (Black & Wiliam, 1998, 2003). More recently, the term assessment as learning has been used to emphasize the active role of the learner as the critical connector between assessment and learning (Earl, 2003, Earl & Katz, 2006), and assessment as a process of metacognition for students (Berry, 2008). With guided instruction from the teacher, students develop their capacity to reflect on, monitor and assess their own learning. As societal change has put a greater onus on students to demonstrate independent and critical thinking, assessment as learning has a crucial role to play in helping students take charge of their learning, develop autonomy, and better prepare themselves for tomorrow's world. presentation will explore ways in which classroom assessment in the English classroom, through a stronger focus on assessment for and as learning, can be turned from a curse into a blessing for both teachers and students.

Challenging the Standards and Argument Approaches and Offering an Ethical Basis for Assessment Evaluation

Despite the publication and influence of the Standards for Psychological and Educational Studies (US-based APA, AERA, and NCME, 1954 to 2014), the impact on language assessment has been minimal. The main reasons could be numerous: (1) the Standards are seen as an idealized set of practices with no connection to the practical world of assessment agencies; (2) the Standards are seen as best practices developed by theoreticians and directed to researchers; (3) the Standards do not have principled reasoning behind them; they are lists of things to do; (4) the Standards did not trickle down to training and education programs in assessment.

An alternative approach, the Argument-based approach (Kane, 2012; Bachman and Palmer, 2014) to evaluation of assessments has

challenged the Standards approach in the last decade. But its appeal mainly rests on using the Toulmin approach (with claims, warrants, backing, rebuttal etc.) that is used to map the argument. This approach has not received wide acceptance in terms of publications or acceptance among assessment agencies for the following reasons: (1) the approach provides a framework and graphical model with plenty of new and somewhat unclear terminology; (2) the acceptance or rejection of arguments are not clearly articulated; and (3) the approach does not relate to the assessment professionals and practitioners as it works as a top-down approach and involves only researchers.

In Kunnan (2017), I proposed a new approach that uses an ethical basis with practical assessment-related scenarios. This approach requires the use of ethical thinking by professionals and practitioners in evaluating dilemma-type scenarios with the support of ethical principles. Such an approach can be seen as a ground-up approach that can involve all practitioners not just researchers. In addition, this approach can be used in education and training programs as the scenario-based approach uses dilemmas that commonly occur in everyday assessment settings.

Why Systemic (not Systematic) Functional Linguistics?

Perhaps because he was a language teacher turned linguist, M.A.K. Halliday maintained a perspective on language, called Systemic Functional Linguistics (SFL), which is grounded in how we actually use language to construe reality and enact social relationships.

By prioritizing the study of function over form, SFL provides the theoretical and methodological basis for investigating 'the aesthetic and functional values that differentiate one text from another, or one voice from another within the frontiers of the same text' (Halliday Collected Works, Vol. 2, chapter 6, p.187).

Only objective linguistic scholarship using the categories of the description of the language as a whole, not 'ad hoc, personal and arbitrarily selective statements', can contribute to the analysis of texts and allow for 'the comparison of each text with others, by the same and by different authors, in the same and in different genres' (Halliday [1964] 2002: 5, 6).


In SFL, the primary focus is on meaning, and how form is used to realize that meaning. Meaning means more than just the ideas expressed, i.e. more than just ideational meaning. When we speak, we also enact a social relationship with our listener(s)/reader(s). Halliday refers to this as interpersonal meaning. Finally, there is textual meaning, or how ideational and interpersonal meaning is formed into the message, whether in speech, writing, or via some other medium/modality.

Patterning in both lexis and grammar contributes to the cohesiveness of a text (i.e. its texture) rendering a coherent rhetorical structure possessing both breadth and depth (its architeXture).





When organisational and professional values collide: Ethical decision making in the context of complexity

Some of the most difficult situations that human service and social work practitioners have to navigate happen in the context of tensions between organisational requirements and professional values. Organisations typically operate under a number of mandates, which demand adherence to legal parameters, socially acceptable boundaries, political imperatives and employment contracts. What a human services practitioner may feel morally obliged to do, in the best interests of their clients, may not be what is allowed or permitted under an organisational directive.

ethical When an ensuing dilemma is experienced by a practitioner, it is useful to consider an ethical decision making process that includes attention to determining accountability, considering cultural dimensions, critically reflecting on past actions, options and potential consequences, and engaging in consultation where appropriate. This presentation will consider ethical decision making in cases where human service practitioners need to advocate for clients in a sometimes hostile environment.

Social Work Professional Ethics in Chinese Society: Practice Dilemma and Recommendations

'Human feelings', 'relationship', 'face' and 'reciprocity' are considered as the core norms of interactive relationship in Chinese society. From an ecosystem point of view, the treatment of social work clients involves the intervention of multiple systems. As far as role responsibility is concerned, the professional role of social workers is moral intervention, with statutory power to allocate welfare resources. According to western professional ethical principles, a human society will face with ethical problems, such as system conflict mediation, fair resource distribution, whistle-blowing, self-determination, use of authority and professional relationship boundary. Therefore, there is a need to strengthen the construction of professional knowledge, skills and ethical principles suitable for Chinese community; and educate students to enhance their competency in dealing with human affairs and relationship.

In my presentation, I shall ask a simple but basic question: why social work? We believe that social work comes from the values, it is a part of our core values, it strive for preserving and pursuing the humanistic values, and supported by the professional values. However, when we mention about values, we need to be clear about what kinds of values that we are talking about. Are they personal, professional, organizational, social, political or spiritual Different values values? exist in contemporary societies, but they may not be the same. Sometimes, there are tension and even conflicts with one another.

This explains why practice of social work by nature is a dynamic and complicated processes. In the processes, we need the values to be the guide for our direction and sustain our efforts. Otherwise, the means may overshadow the meaning, we shall be fully engaged with doing


but forget thinking and dreaming. Without values commitment, social work professionals will become only social technocrats. The roles and functions of social workers are well-being of the people from the birth to the death. Sometimes, we may not solve the problem with our clients. However, at least, we can serve as partner to listen and help, to empower and advocate, of course, with the belief in love, self-determination, and social justice.

With a self-reflection over the practice in the past 40 years, I would like to share some of my ideas and ideal with fellow workers to revisit the base of social work practice: is social work "relationship-based", "client-based", "evidence-based", "value-based" or a mixture of all/some of these components?

Research Workshop on Bioinformatics (15/6/2017)

Medical Image Retrieval in Peer-to-peer Networks

Dr CHEN Wei Chinese Academy of Agricultural Sciences

Computed tomography is considered one of the most reliable methods in the early detection of some kinds of diseases, e.g., retrieval of some cancers. Effective computed tomography images is beneficial for computer-aided diagnosis. Due to the large amount of computational power needed for the processing of medical images, as well as the fact that medical images are often naturally distributed over hospitals, peer-to-peer data mining and information retrieval techniques can be utilized in the searching and processing of those images. In this presentation, a distributed image retrieval approach is introduced peer-to-peer networks and applied to the medical image retrieval field. **Preliminary** experiments are also presented for the evaluation of the proposed method.

Big Data Analysis in Bioinformatics: A Machine Learning Perspective

Dr OUYANG Le Shenzhen Key Laboratory of Media Information Content Security Shenzhen University

With the advance in technologies capturing molecular and medical data, we entered the area of "Big Data" in biology and medicine. availability of big data provides unprecedented opportunities but also raises new challenges for data mining and analysis. As high-throughput data acquisition becomes popular in biomedical research, it is timely to propose some novel approaches to mining the large-scale genomic data to find new genetic patterns. In this talk, I will first introduce key concepts in the analysis of big data, including both "machine learning" algorithms as well as "unsupervised" and "supervised" examples of each, and provide a brief overview of recent developments in big data analyses in the context of precision medicine and health informatics. Next, I will introduce our previous contributions in this area, including ensemble learning, multi-view learning, biomarkers discovery and differential network analysis.

Research Workshop on Big Data (7/7/2017)

Event Cube: a Conceptual Model for Multi-sourced Event Discovery and Analysis

Prof Qing LI

The Director of the Engineering Research Centre on Multimedia Software, City University of Hong Kong

The publicly available data such as the massive and dynamically updated news and social media data streams (a.k.a. big data) covers the various aspects of social activities, personal views and expressions, which points to the importance of understanding and discovering the knowledge patterns underlying the big data, and the need of developing methodologies and techniques to discover real-world events from such big data, to manage and to analyze the discovered events in an efficient and elegant way.

In this talk we introduce techniques of discovering events from the multi-modal big data and building an event cube model to support event queries and analysis, by addressing the tasks of data cleansing, data fusion, event detection and modeling. Preliminary experimental results on some of the tasks will be reported.

We further explore and connect the important events discovered in a multimodal collection of inputs from various public sources, uncover their co-occurrence and track down the spatial and temporal dependency to answer the challenging questions of "how" and "why".

A novel event cube (EC) model is devised to support various queries and analysis tasks of events; such events include those discovered by techniques of untargeted event detection (UED) and targeted event detection (TED) from multi-sourced data. More specifically, based on essential event elements of 5W1H, the EC model is developed to organize the discovered events from multiple dimensions, and to operate on the events at various levels of granularity, which facilitates analyzing and mining hidden/inherent relationships among the events effectively.

User Modeling for Big Data in Education

Dr Haoran XIE

With the rapid development of Massive Open Online Courses, open educational resources, social communities, and ubiquitous technologies in recent years, there is a fast growth of educational resources such as online platforms, course videos, web pages and documents. Practical and innovative approaches to the use of these eResources, despite of their importance, are not familiar to many people. Therefore, an effective and efficient user model, which improves learners' information literacy and learning effectiveness, is necessary organization of big data. In this talk, user models domain-specific educational applications are introduced to give some insights on the research question of how to model a user in e-learning systems in the big data era.

Graphical Models for Web Mining Applications

Dr Tak-Lam WONG

Assistant Professor cum Associate Head, Department of Mathematics and Information Technology

The Education University of Hong Kong

In this talk, graphical models and its application to Web mining will be discussed. The first part presents a work for tackling Web query re-formulation via joint modeling of latent topic dependency and term context. The proposed model exploits a latent topic space, which is automatically derived from the query log, to detect semantic dependency of terms in a query and dependency among topics. The graphical model also captures the term context in the history query by skip-bigram and n-gram language models. In the second part, an unsupervised learning framework for extracting popular product attributes from product description pages originated from different E-commerce Web sites will be presented. Our proposed framework is able to not only detect popular product features from a collection of customer reviews but also map these popular features to the related product attributes. One novelty of our framework is that it can bridge the vocabulary gap between the text in product description pages and the text in customer reviews. Technically, we develop a discriminative graphical model based on hidden Conditional Random Fields. As an unsupervised model, our framework can be easily applied to a variety of new domains and Web sites without the need of labeling training samples.

Artificial Intelligence and Multimedia Big Data (27/7/2017)

Generative Adversarial Networks: A New Age of Artificial Intelligence

Mr Xudong MAO Alibaba Group

This talk focuses on the topic about Generative Adversarial Networks (GANs). Recently, GANs have achieved great successes in various computer vision tasks including image generation, image super-resolution, and image-to-image translation. This talk will provide a comprehensive description of GANs from the theoretical foundation to the applications. To begin with, we will describe that why GANs are worth studying. Then, the theory and framework of GANs will be introduced. Next, we will introduce some recent works and research frontiers in GANs. Finally, several state-of-the-art applications of GANs will be presented.

Feature-preserving Surface Mesh Smoothing, Denoising and Applications in Biomedical Modeling

Dr Mingqiang WEI Nanjing University of Aeronautics and Astronautics

3D surface meshes are widely used in computer graphics and applications. Even with state-of-the-art scanning devices, the scanned surfaces inevitably contain noise due to various sources. Noise not only degrades the visualization quality, but also causes troubles in the downstream processing. Removing noise while preserving features at various scales, as well as avoiding to introduce

additional artifacts, is a challenging task for surface mesh smoothing and denoising. In this talk, we give four promising solutions. Firstly, we propose a robust two-step approach which consists of a joint bilateral filter and a constrained global Laplacian filter. Secondly, we propose a coarse-to-fine normal filter based on a widely-accepted geometry assumption. Thirdly, we propose a bi-normal filter by taking advantage of the piecewise consistent property of two normal fields on surface meshes. Finally, we propose a conceptually simple approach that provides a united framework for not only handling artifacts (e.g. noise, staircases), but also for enabling the morphology preservation of anatomical structures of human organs.

Active Learning Under Complex Scenarios

Active Learning is a revised supervised learning scheme that adopts selective sampling manner. It addresses the interaction between Machine Learning/Data Mining algorithms and human feedbacks, reduces the human efforts for manual labeling, avoids data redundancy, and improves the computation speed of Machine Learning tools. For examples, a high-performance learner can be achieved with a small portion of the data set by querying the labels of the most representative samples and requesting the most relevant information. As a result, active learning bridges the gap between data-centric and user-centric approaches. It is a very useful methodology when there is a need to perform interactive model evaluation and model updating for both off-line and on-line applications. Active learning has been studied for many years under binary settings, where multiclass active learning is much less studied. It has also been investigated for many

years under the traditional single-instance and single-label settings, where each data point is dependent of the others and is belonging to a specific class. On one hand, these learning methods are not applicable to complex scenarios, such as multi-instance and multi-label settings. On the other hand, with the rapid expansion of existing data, there are still gaps between theoretical research and practical applications. When designing active learning methods for complex scenarios, new issues are raised, including the design of multi-instance or multi-label learners, feature selection methods, sample selection indices, stopping criteria, and performance evaluation metrics, etc. In order to adapt active learning to big data problems, methods must be able to handle data with high volumes and high-dimension, with the ability of mining useful information from increasingly large data streams. This talk will introduce some of the most recent research outputs on active learning under complex scenarios, such as multiclass active learning, multi-instance active learning, and multi-label active learning, etc. Techniques of fuzzy rough sets, kernel-based clustering, and multi-criteria decision making, etc., can all be applied to related domains. Some emerging issues, such as the design of base classifier, sample selection criteria, and performance evaluation metrics, etc., will also be discussed.

Low Complexity HEVC Encoder for Efficient Big Video Data Compression

The high definition (HD) and ultra HD videos are widely applied in multimedia applications. However, with the increased resolution of video, the volume of the raw visual information data increases significantly, which becomes a challenge for storage, processing, and transmitting the big visual data. The state-of-the-art video compression standard-high efficiency video coding (HEVC)

compresses the raw big visual data efficiently, while the high compression rate comes at the cost of heavy computation load. Hence, reducing the encoding complexity becomes vital for the HEVC encoder to be used in multimedia applications. In this talk, the foundations of HEVC encoder will be firstly intro duced. Then, the video content characteristics based low complexity encoding methods will be introduced. Experimental results show that these low complexity encoding methods can efficiently reduce the computational complexity of HEVC encoder, meanwhile, the rate distortion performance degradation is negligible.

Research workshop on Educational Technology (4/8/2017)

Key to the Success of E-learning Studies - Strategies of Finding Innovative Research Topics

Prof Gwo-Jen HWANG National Taiwan University of Science and Technology, Taiwan

Finding a good research topic is one of the most important and challenging tasks for researchers. Most papers submitted to well recognized journals are rejected owing to the lack of innovations in the studies. In this talk, I am going to present the strategies for finding innovative e-learning research topics as well as the criteria of publishing a quality paper. In addition, several authentic examples will be given to demonstrate how the value of an e-learning study can be promoted.

Research Outcome that Support Teachers Teaching and Students Learning Online

Dr Maiga CHANG School of Computing Information and Systems Athabasca University, Canada

The talk aims to introduce the most recent technologies that my research group has done for assisting teachers, students, researchers and schools. The technologies included in this talk are Automarking, Online Test System, In-game Card as Education Reward (ICER) Moodle plug-in, and the bridge -- Educational Resource Information Communication (ERIC) API. Automarking is a computerized marking mechanism for marking students' short-answers based on the semantic meaning of those answers. The Online Test

responsive System (OTS) is а implemented to provide teachers with end-to-end solution to streamline student assessment process as well as saving them time and efforts of preparing test items -- the system can automatically generate items, based on the knowledge map teachers created, for teachers to pick-up and form their tests. The ICER (In-game Card as Educational Reward) Moodle plug-in aims to evaluate students' performance on learning activities in Moodle and delivers them in-game items as rewards. Whenever students complete learning activities (e.g., assignments, quizzes, and discussions), the reward plug-in decides whether or not an educational reward which they can use in the game should be given according to the predefined criteria their teacher set. The ERIC API enables the integration of separate systems and enhance their interoperability while keeping any of the systems working independently like they were.

Research Workshop on Natural Language Processing for Big Data (16/8/2017)

Information Extraction from Large Scale Clinical Trial Texts

Dr Tianyong HAO
Associate Professor and Yunshan Scholar,
Guangdong University of Foreign Studies

Clinical trials generate highly relevant evidences for effective disease treatments. The extraction of necessary meta information for patient characteristic aggregation from a large scale of clinical trial texts through natural language processing remains a research problem due to the complexity of the unstructured texts. By collaborating with a research group at Columbia University Medical Center based on EliXR project, our research group has made some progresses on natural language processing. This talk will briefly present our recent research on: an extensible approach for automated semantic tag mining; TEXer - temporal expression extraction and normalization; TrialSmart personalized search of clinical trials through preference learning; clinical trial clustering by similar semantic phenotypes; Gior - a virtual population gender architecture for fast enhancing clinical trial recruitment. Particularly, we will describe Valx - a system for quantitative information extraction and normalization from clinical trial texts in detail.

Integrating Feature Weighting in Topic Models

Prof Yi CAI
South China University of Technology

Latent Dirichlet Allocation (LDA) and its variants have been widely used to discover latent topics in textual documents. However, some of topics generated by LDA may be noisy with irrelevant words scattering across these topics. We name this kind of words as topic-indiscriminate words, which tend to make topics more ambiguous and less interpretable by humans. In our work, we propose a new topic model named TWLDA, which assigns low weights to words with low topic discriminating power (ability). Our experimental results show that the proposed approach, which effectively reduces the number of topic-indiscriminate words in discovered topics, improves the effectiveness of LDA.



Research Capability Enhancement

Big Data Analysis in Healthcare: theory and applications

The healthcare industry has generated large amounts of data, including patient data in electronic patient records, sensor data from monitoring vital signs, and patient-specific information on Twitter feeds (so-called tweets), Facebook status updates, blogs, and web pages. Although analyzing the massive amount of healthcare information is valuable to better clinical decision support and accurate predictions of disease, it requires high performance computing platforms and algorithms. By discovering associations and

understanding patterns within the data effectively, big data analytics has the potential to improve care, save lives and lower costs. This talk will describe classification and clustering methods to facilitate diagnosis. The classical data mining algorithms, such as decision trees, Apriori, k-means along with their limitations will be The challenges and future summarized. directions of big data analytics in healthcare will also be discussed.

Learning from Uncertainty for Big Data

Big data refers to the datasets that are so large that conventional database management and data analysis tools are insufficient to work with them. Big data has become a bigger-than-ever problem with the quick developments of data collection and storage technologies. Model simplification is one of the most popular approaches to big data processing. After a brief tutorial of the existing techniques of processing big data, this talk will present some key issues of learning from big data with uncertainty, focusing on the impact of handling uncertainty on the model simplification. It shows that the representation, measure, and handling of the uncertainty have a significant influence on the performance of learning from big data. Some new advances in our Big Data Institute regarding the research on big data analysis and its applications to different domains will be briefly introduced.



Achieving Methodological Rigour in Qualitative Research

This seminar will present assertions that findings of qualitative research are trustworthy and transferable if the methods used are rigorous and if the facts derived from the research are representative in the concept, as opposed to representative in the number, and are proven in accordance with the standards of proof in law or science such as in particular the concept and strength of evidence. Examples will be given to demonstrate how data saturation can be achieved through conscientious effort in data collection for example, by using theoretical sampling and identifying negative cases, and in data analysis for example by mandatory presentation of logical trees and total number of units of information. Other methods that are widely used to enhance methodological rigour will also be presented and examined, for example, the dos and don'ts of using focus groups, and the use of good practices in data collection use of multiple raters establishment of audit trails, as well as good practices in data analysis such as assessment of data quality. Participants are encouraged to raise challenges that they have come across for discussion and identifying solutions.





Data Mining in Health- and Bio-Informatics

With the rapid development of computer techniques, data mining and machine learning have played an important role in multiple research areas. Especially in health- and bio-informatics, such data-driven analytics hold great potential to reveal patterns/correlations, identify inefficiencies, provide quality care and reduce costs. Therefore effective data mining and analytic strategies are urgently required in these studies. In this talk, we provide two data mining applications in healthbio-informatics, to illustrate the potential of data-driven methods in these areas. First, a study of stratifying patients with chronic diseases into different expenditure and healthcare-utilization patterns (cost/ length-of-stay), based on flattening and massive electronic aggregating medical records (EMRs), and profiling the patient groups is presented. Such studies can provide useful insights into the strategy-design of reducing healthcare costs and optimizing facility utilization in health systems. As the application, pattern second mining EGFR-mutated non-small-cell lung cancer studies, based on the characterization of EGFR mutant-inhibitor interactions and exploration of EGFR downstream signaling networks, is presented. Molecular dynamics (MD) simulations and three-dimensional (3D) structural analysis are primarily applied in these studies, and they can promote the development of personalized care innovative drug discovery.

XBRL Research Development and an Example of FDS Grant Application

What's next?

The scope of research work has been within one of CIHE's five Schools, with little collaboration across Schools within the Institute. Over the past two years, there has been a significant enhancement of research culture and academics' research capability as well as intra- and inter-institutional collaboration. Strategically, this has helped in overcoming the limitations common to the relatively small self-financing degree awarding institutions in Hong Kong.

CIHE has Caritas — Hong Kong as the sponsoring organization and thereby can access great opportunities for collaboration in their diversified social, health and education services. We are deploying this strong network, to develop interdisciplinary research, leveraging rich data collection and field study opportunities in the 240 service units of Caritas — Hong Kong. Notable is the unique "Caritas Hong Kong Jockey Club Carers Support and Resources Centre", which is a practicum-cum-service-cum-research platform established on our campus, between CIHE and the Social Services Division of Caritas — Hong Kong.



Besides Research Grants Council (RGC) grants, external funding has also been won for supporting scholarly activities in preventive health management (such as osteoporosis) as well as research on facilitating upward mobility of secondary school students. Project Get-Set-Go, for example, has enabled CIHE academic staff to perform research and reach out to deserving, but under-served secondary students, to help those in secondary 4 to 6 prepare for future education and employment opportunities.

Integrating research, teaching and services will be our over-arching objective. We shall focus our expertise with critical mass on areas of the greatest social needs, such as community health, elderly care and special education needs, where the direct and associated programme areas of our diverse portfolio can be brought be bear on healthcare, counselling, technology, policy/social enterprise model, design, and ethics, thereby informing policy makers and professional practitioners in making decisions for better quality of life.
